The tender fee should be in the form of Pay Order in favour of KIDCL Submission of application for issuance of bid documents along with copy of valid PEC registration certificate in Category CA, Discipline CE-01, CE-02 and CE-10 are mandatory for issuance of bid documents.
5. Bid Security of all technical bids must be accompanied by a Original Bid Security in the amount of Rs. 50 million in the shape as stated in the bidding documents.
