i.	Valid Income Tax Registration Certificate
ii.	Valid Sales Tax Registration Certificate (Status = Active with FBR)
iii.	Authorization of the principal / manufacturer / distributor / reseller certificate for items in Price Schedules for Goods.
iv.	Firm's at least 10 x similar projects executed/work orders undertaken in Pakistan with minimum worth of Rs. 100 Million or more each during the last 03 years for items mentioned in Price Schedules for Goods. Documentary proof/evidence required. Attach work/supply order/contract agreement/ completion certificate.
v.	Firm should be in operations for more than 03 years (Certificate of incorporation/ registration under the laws of Pakistan – Documentary proof/ evidence required)
vi.	Annual Turnover of Rs. 100 Million or more on average during the last three years' Documentary proof/evidence required. (Attach financial statements)
vii.	Bidder must provide an Affidavit on Non-judicial E-Stamp paper of Rs. 100/- that bidder has never been under investigation for offence related to corrupt and fraudulent practices, under-invoicing, tax evasion, concealment, money laundering import of products from grey channel, etc.
viii.	Bidder must provide an Affidavit on Non-judicial E-Stamp paper of Rs. 100/- stating that the bidder is not blacklisted by any public sector organization in Pakistan
ix.	Details of litigations (if any) for default of services on Non-judicial E-stamp paper of Rs. 100/-
x.	Bid Security - Submission of valid bid security at 2% of quoted price
xi.	Technical Compliance - All quoted items must meet or exceed the specified technical specifications.

- The Bidders are required to upload their Proposals (Financial & Technical) on E-PADS latest by the date & time of submitting the proposal
- Original Bid Security at 2% of quoted price in the shape of CDR/Pay Order/ Bank Guarantee (any scheduled Bank of Pakistan) and Tender Fee **Rs. 3,000/-** in shape of Pay Order (mentioning name of the Contractor and in favor of **Pakistan Infrastructure Development Company Limited**).
