- Applications, which are incomplete/not signed/not stamped/late or submitted by other than specified mode will be rejected. The contract will be awarded to the most advantageous bid.
- Bank Draft/Pay Order of 2% of quoted value in favor of **Pakistan Infrastructure Development Company Limited, Karachi** is to be delivered office of General Manager Administration/C.F.O, PIDCL, Karachi, before the bid closing time as earnest money, otherwise tender shall be rejected.
- The bidders shall be on Active Taxpayer List (ATL) and shall be Sales Tax return filer.
- Bidder firm shall attach an affidavit on E-stamp paper (Original) to the effect that firm has not been black listed by any of the Govt. Departments. Same may be delivered with earnest money.
- The quotations may be submitted inclusive of all applicable taxes and all applicable Taxes will be deducted in accordance with the law.
